Hugh Freeze was named the 31st head football coach in Auburn's 132-year history on Nov. 28, 2022. An experienced head coach at the collegiate level for 14 years, Hugh has quickly elevated each program he's led, including Ole Miss and most recently, Liberty. Hugh has nearly three decades of continued coaching success, including head coaching experience that has led to conference titles, nationally ranked recruiting classes, and bowl appearances at multiple stops during his highly decorated career.

Born in Oxford and raised in Independence, Mississippi, Hugh received an associate's degree from Northwest Mississippi Community College in 1990 and was a two-year letterwinner on the Ranger baseball team. He earned his bachelor's degree in mathematics with a minor in coaching and sports administration from the University of Southern Mississippi in 1992.

It was while attending Southern Miss that Hugh met Jill, his wife of 34 years. Originally from Louisville, Miss., Jill obtained her bachelor's degree in mathematics and secondary education. She went on to receive her master's degree in secondary education, and taught high school students for more than 10 years.

Jill's strong faith and family background, as well as her own athleticism, are largely responsible for her desire to do her part in helping Hugh in his role of head coach. While she shares his primary goal of giving his players the tools they will need to succeed in life long after football, Jill believes her calling is to support the wives of the coaches. For the wives, Jill often leads Bible studies and seeks to mentor those who are new to the role.

Faith, family, football, and philanthropy define the lives of the Freezes. And they wouldn't want it any other way.

Hugh and Jill are the parents of three daughters, Ragan, Jordan, and Madison, and grandparents to two granddaughters. They are also members of the Women's Philanthropy Board with Hugh serving as "Mr. September 2024" in the Phils calendar.

With more than two decades of experience as a coach and administrator in the Southeastern Conference, John Cohen was named the 16th Director of Athletics at Auburn University on Oct. 31, 2022. Cohen spent the previous 14 years at Mississippi State in various capacities, most recently as the athletic director from 2016-2022

Throughout Cohen's first 20 months at Auburn, athletics programs have achieved tremendous success, highlighted by men's golf winning the 2024 national championship, the 23rd national championship in the history of Auburn Athletics, as well as a pair of national runner-up finishes from men's track & field (2024) and equestrian (2023). Twenty of 21 programs have advanced to their respective NCAA postseason tournaments under Cohen's leadership.

Cohen's career in college athletics began as a baseball player at Mississippi State. He then spent 25 years in the coaching ranks including being named a two-time SEC Coach of the Year.
